You will be able to ask questions, compare plans, and find out what you need to do before the end of open enrollment which is October 31.

### YOUR NEW MEDICARE CARD IS ON THE WAY

If you have not received your new card, be looking out for it. It is not the laminated card you are used to. It is a simple paper card, but it is important that you start using it as soon as you receive it. The card omits all SOCIAL SECURITY NUMBERS and ADDRESSES. It simply has your name and the It is still Medicare Number. necessary for you to GUARD YOUR CARD, but it lessens the chance of identity theft using your social security number.

# THINGS TO KNOW ABOUT YOUR NEW CARD

Mailing takes time—it is coming.

Guard your card. Only give your new number to doctors, pharmacists, and other health care providers, or insurers. Your new card has a different number unique to you.

Your new card makes it easier for healthcare workers to make a copy.

Keep the new Medicare Card with you when you visit your doctor.

Your doctor knows it is coming.

You can find your number or print a new card on line if you need to.

Destroy your old Medicare Card once you receive the new one, BUT keep the United Health Base or Enhanced Card. If you are on the Medicare Advantage Plan Base or Enhanced, your old card is still your main card for Medicare, but you may be asked to show your new Medicare Card, so you should carry both.

### **DID YOU KNOW....**

Your Medicare Advantage Plan through United Health Care gives you one FREE eye exam per year. It does not pay for your lens or frames.

If you are paying for a Vision Plan through Pierce Insurance Agency or Superior Vision, it should help with the lens and frames.

Take advantage of it.

# Open Enrollment <sup>is</sup> September 29 – October 31, 2018

All Medicare members currently enrolled in the 70/30 Plan will be automatically enrolled into the United Health Care Group Medicare Advantage Base Plan effective January 1, 2019 if no action is taken during Open Enrollment.

You will need to take action during Open Enrollment if you want to be enrolled in a different plan option.

If you are currently enrolled in a United Health Care Group Medicare Advantage Plan, you do **NOT** need to take any action during Open Enrollment unless you want to change plans or need to add dependents.
